

YMCA of Greater Brandywine Volunteer Clearance Instructions

Volunteers are required to submit original clearance documents to the designated Volunteer Coordinator at their home branch. Original documents will be verified by the Volunteer Coordinator, and copies will be kept in a confidential file.

Act 34 Pennsylvania Criminal History Check (Cost to Volunteer determined by agency)	This is an online procedure. Click on the following link and go to "Submit a New Record Check." Follow the instructions through to the Certification Page. Once the Search results Table appears, click on the Control Number. Please be sure to retain the control number for your records. Click on the Certification Page to access your official Clearance. The Record Check Details page is only a receipt and not acceptable as a "clearance." Act 151 Pennsylvania Child Abuse History Check (Cost to Volunteer determined by agency)	This is an online procedure. Once you click on the link you will be directed to the Child Welfare Portal where <u>you must create</u> <u>an account or log in if you already have an account</u> . Note: you will need an email address to create an account. Creating an account and submitting your clearance application online will give you immediate access to your results or the status of your results if your results cannot be processed immediately. Act 114 FBI Criminal History Report \$27.00 (Cost to Volunteer determined by agency)	 Volunteer Requirements: 1. The applicant MUST register PRIOR to going to the fingerprint site. Registration is completed online or over the phone. Registration is available online 24 hours/day, seven days per week at www.pa.cogentid.com. Telephone registration is available at 1-888-439-2486 Monday through Friday, 8 am to 6 pm EST. Make sure you register for the Department of Human Services FBI clearance. 2. The applicant MUST make their payment online at www.pa.cogentid.com PRIOR to going to the fingerprint site. 3. On the day of the fingerprinting, the applicant must bring a. A valid driver's license of other approved photo ID. b. The confirmation number received upon registration. Any Level II or Level II Volunteer who has lived in PA for the last 10 years will need to sign an affidavit.
